foreword

We are pleased to present the second activity report of the French Red Cross Foundation, dedicated to humanitarian and social research.

Following on from 2018, which marked the beginning of its activities, the Foundation worked throughout 2019 alongside its governance, researchers, and partners, on the development of its strategic plan for 2020-2024. The aim: to continue to transform the practices of actors of international humanitarian and social action, with the help of the social sciences. As well as its research programme on humanitarian transition, the Foundation's missions are therefore now organised according to three topics: access to health and epidemics, migrations and population movements, and risks and disasters. Metropolitan France, the overseas territories and sub-Saharan Africa have been confirmed as priority research areas. As a result, we wanted to reinforce the Scientific Council, with the arrival of four new members whose renowned scientific credentials are in perfect keeping with these focus topics and geographical areas.

This strategic plan informed the launch, follow-up, and implementation of more than a dozen research projects across four continents, several publications, and the organisation of events and meet-ups. 2019 featured several highlights in this regard. In February, in coordination with the IFRC, the Foundation welcomed the Reference and Expertise Centres of the Red Cross Movement in Paris for their global workshop. In April, the Foundation was an active partner for the Global Conference on health and climate change, organised by the French Red Cross in Cannes, and for the international seminar for the 10th anniversary of the France-Japan Foundation. The setting up of partnerships with the Agence Universitaire de la Francophonie (AUF) and The Conversation also highlighted the importance of strategic partnerships within the Frenchspeaking world.



Finally, 2019 was a year of more concerted work with the business divisions of the French Red Cross, which encouraged visits to the Red Cross campus by a number of researchers, the co-development of research programmes, documentary screenings, and presentations of results. The *Bénévo'Lab* project was also launched in 2019, aimed at those practitioners who work daily to alleviate people's suffering on the frontline of operational concerns, offering them the opportunity to take part in a researcher's work over the course of a year.

The Foundation's second year of activity has been rich, diverse, and ever more solidly anchored in its core missions. This report is the promise of a foundation that is developing and finding its place, whilst advocating ceaselessly for a reinforced collaboration between the International Red Cross and Red Crescent Movement and the scientific community.



Research

In 2019, the Foundation evaluated and selected **22 Francophone researchers, operating in 9 countries**: 19 postdoctoral fellowships were allocated (11 in the research year 2018-2019 and 8 in 2019/2020), 3 research prizes were awarded. In spite of differing sensibilities, approaches and areas of expertise, these researchers share a common goal: to bring to light the realities in the field as well as the needs of aid-recipient populations, using the tools of the humanities and social sciences, in order to enable the emergence of innovative and sustainable solutions for humanitarian and social action.



Project focus

Post-disaster solidarity mechanisms: a comparative analysis to better anticipate crises

Annabelle MOATTY

Doctor of Geography - Paul Valéry University, Montpellier (France)

Annabelle Moatty's research aims to analyse the solidarity mechanisms implemented in the aftermath of Hurricane Irma in two territories of the French West Indies, Saint-Martin and Saint-Barthélémy. The idea is to understand the weight of these mechanisms in the processes of post-disaster resilience and adaptation on different levels.

This research fills a gap in the existing knowledge relating to the obstacles that slow down countries' emergence from crises and impede resilience. This is particularly problematic in the French context, where actors have access to a number of crisis management plans on different levels, from the totality of the affected area to individual households, but no post-crisis management plan. In the absence of planning, recovery is conducted according to administrative procedures which are implemented immediately after the crisis, resembling an adaptation by derogation of existing procedures.

Annabelle Moatty's work relates to the great environmental and social issues of our century, i.e. the protection of populations in extreme situations (60 000 people live at less than 10 metres above sea-level on the coast of Guadeloupe), issues of sustainable development and regulation of urbanised spaces in danger zones in order to reduce the cost of disasters, and issues of development, imagining less vulnerable territories.



Bénévo'Lab: volunteers for research

Bénévo'Lab is a new research programme of the Foundation, which is to be initiated by those leading daily actions for the French Red Cross - that is, the volunteers. The idea is to enable volunteers who express the need to better understand a social issue to join forces with a researcher, selected and accompanied by the Foundation, who will carry out tailored research, in close collaboration with the volunteer, over the course of a year.

By means of this new programme, the Foundation bears witness to the will of the French Red Cross to grow, adapt and transform itself together with the sciences, in order to reinforce the actions carried out by the volunteers for the benefit of the most vulnerable.

Two major events for the Foundation take place each year. Firstly, the Rencontres de la Fondation, where researchers from the current year present the results of their work in Paris. This is followed by the International Conference "Humanitarian Transition", organised each year in a priority research country, during which the Foundation fosters dialogue between the academic sector and the operational environment in the field, as close as possible to local realities.

2019 International Conference

1st event in English-speaking Africa

The Foundation's sixth international conference took place in Nairobi on 29 and 30 October 2019. This event, the first to be held in English-speaking Africa, was the result of a long-standing collaboration between the Foundation and its partners: the Kenyan Red Cross' International Centre for Humanitarian Affairs (ICHA) and the *Institut de recherche pour le développement (IRD)*.

Over 100 participants from a dozen organisations (international and national NGOs, universities, UN agencies, state actors) representing humanitarian action in Kenya and East Africa gathered to analyse and debate the topic of humanitarian transition in Kenya. The aim was to collectively analyse the development of causes of crises and to work towards the transformation of responses, on the basis of solutions and concrete cases unique to Kenya: the management of effects of disasters linked to climate hazards, the urbanisation of crises and responses, new practices and innovations, such as *Forecast-based Financing*, or the use of biometric technologies amongst refugee populations.

Following five events organised in francophone countries in Africa and the Middle East (Senegal, Côte d'Ivoire, Madagascar, Lebanon and Cameroon), this conference in English-speaking Africa gave the Foundation the opportunity to build academic bridges between these two great regions on the African continent. Marie-Thérèse Mengue, a professor of sociology at the *Université catholique d'Afrique de l'Ouest (UCAC)* in Cameroon, and Georges Djohy, a researcher in anthropology at the University of Parakou in Benin and a Foundation fellowship laureate, were able to put the humanitarian situation in Kenya in perspective with reference to their respective countries. With the support of the Agence Universitaire de la Francophonie (AUF), the Foundation was able to fulfil its mission of scientific collaboration between anglophone and francophone research worlds, thanks to the simultaneous French-English translation of the conference.

The *Rencontres de la Fondation* 2019 3 thematics at the heart of humanitarian action under discussion

On Wednesday 25 September 2019, the French Red Cross Foundation held its second annual meeting for humanitarian and social research. This *Rencontres de la Fondation* event, hosted this year by the Cité internationale universitaire in Paris, in partnership with the *Agence universitaire de la Francophonie (AUF)*, brought together nearly 100 people, including academics, field operatives, journalists, students, heads of NGOs, and representatives of the Red Cross Movement



It was the opportunityto present the results of the eight researchers whom the Foundation had supported and accompanied over the course of 2017-2018. The eight laureates

outlined their research projects, all of which were carried out in francophone sub-Saharan Africa, before putting them into perspective and opening them up for debate. This year, their scientific projects shed light on three subjects at the heart of humanitarian aid: food security and autonomy, access to healthcare, and climate risks. These three topics were the subject of animated debate between the panellists in each round-table discussion – academics, NGOs and sponsors – each acknowledging the importance of taking a step back from the urgency of action.

World Conference "Health and Climate Change" in Cannes



On 15 and 16 April 2019, the Foundation took part in the World Conference on Health and Climate Change, "Taking Care of Humankind at +2°", organised by the French Red Cross on the centenary of the International Federation (IFRC). The conference, which brought together over sixty National Societies, representatives of the International Committee of the Red Cross (ICRC), and research centres, aimed to consider the latest scientific research alongside the responses deployed in order to tackle the defining humanitarian challenge of the 21st century: the impact of climate change on health.

As a partner for the event, and with the aim of promoting knowledge and creating links between researchers and operational agents, the Foundation coordinated the bookstore space at the conference, inviting editors, both anglophone and francophone, that are references in the social sciences, as well as the *Humanitarian Alternatives* review. The Research and Expertise Centres of the Red Cross Movement made their first appearance as a network at the conference, contributing to this space dedicated to sciences and practices by providing knowledge and tools acquired as part of their mission.

Launch of the 'Practices & Humanities' series

Following the recommendation of the Strategic Scientific Review in June 2018, the Foundation has been working to communicate the results of the research it supports in the form of a 4-page overview. The 'Practices & Humanities' series, available, like the articles, in open access on our website, is aimed at an audience of operational agents-humanitarian or social workers-who are familiar with the research subjects addressed by the Foundation, but mainly from the perspective of practices. These professionals do not necessarily have the opportunity to approach these subjects in the same way as scientists, nor to regularly read 15-20-page scientific articles. This series therefore aims to make these results more accessible, in a clear style, without needless jargon or overly theoretical terms, and with a focus on the practical implications of the results of research for humanitarian and social actors.



Devenir Humanitaire Collection



The Devenir Humanitaire collection, edited by the Foundation at Karthala Editions, is a series of bilingual books on the topic of humanitarian transition, each with a country focus. Based on calls for papers launched by academic institutions, each volume contains comparative articles by researchers and operational agents, based on reflections begun during the Foundation's international conference in the country in question. Thanks to the editor's publishing network, these volumes are available in France, but also in a wide network of bookstores throughout Africa.

The fourth volume in the collection is dedicated to Humanitarian Transition in Lebanon. It is the product of the meeting between academics, non-governmental and institutional actors who gathered for the conference in Beirut in November 2017. The fifth volume will focus on Humanitarian Transition in Cameroon, itself in the continuity of the international conference co-organised in Yaoundé by the Foundation and the IRD in November 2018. Both volumes, which will be published in 2020, will present a contextual reading of the main humanitarian issues in the two respective countries, followed by an examination of the particular configurations and interactions that shape the local aid landscapes. The volumes are rounded out by interviews which present the perspective of state and non-governmental actors.

A new reference manual: launch of the Treaty on the Law and Practice of Humanitarian Action

The Treaty on the Law and Practice of Humanitarian Action, launched in November 2019 (LGDJ Editions), has already become a reference manual. Its nearly 900 pages feature contributions from over 80 Francophone experts in humanitarian action, in its legal, political, and ethical dimensions. The Treaty, edited by Sandra Szurek, Marina Eudes and Philippe Ryfman, approaches humanitarian action as an autonomous object of analysis, on the basis of a global vision encompassing all of the circumstances in which it is deployed, from responses to natural disasters to interventions in cases of armed conflict. A number of researchers supported by the Foundation, as well as members of its Governing Board, are amongst the contributors.

The Foundation is pleased to be involved in this project which, by promoting francophone knowledge and practice surrounding humanitarian action, is perfectly in line with its

Presentation of annual accounts

The French Red Cross Foundation was created through the transformation of the Henri Dunant endowment fund. This transformation was registered by the declaration decree of public utility, published on 1 September 2017.

In 2019, there were two financial challenges: to diversify resources in order to achieve a balance by offsetting the exceptional financial flows linked to the Foundation's launch in 2018 and to lay the groundwork for a sustainable development of the Foundation's activities towards its autonomy.

strengthening endowment revenues

The French Red Cross Foundation benefits from an endowment of €4,627,000. Essentially made up of five real estate assets, this endowment enabled revenue from property income. This income finances operational costs, communication expenses, and calls on public generosity, thus enabling to collect financial resources to carry out social missions. Real estate appraisals were carried out in 2018 on all of the properties. For each property, they confirmed a present market value greater than their net book value, thereby guaranteeing the amount of the Foundation's initial endowment.

In 2019, a project to optimise the property portfolio was launched in order to ensure a sound and sustainable property management process. In addition, the French Red Cross approved the reinforcement of the Foundation's endowment until 2021.

a successful funding diversification to finance increasingly operational research

To preserve its independence and carry out its research missions sustainably, the Foundation chose to rely on different sources of funding in France and abroad:

- Real estate revenues deriving from the initial endowment
- Partnerships with the private sector, companies and foundations
- Calls on public generosity
- State subsidies
- Skills-based sponsorships and sponsorships for services

This diversification, consolidated in 2019, has enabled scientific programmes to be deployed in all strategic territories and has enabled the groundwork to be laid for an expanded offer in 2020.

04 financial statement

It should be recalled that in 2018, the Foundation inherited the assets of the Henry Dunant Fund, an endowment fund with real estate activities, as well as the activities and liquidation assets of the French Red Cross Fund and the Fondation pour le lien social. The two financial years 2018 and 2019 are therefore not very comparable in terms of income and expenses, but they are in line in terms of accounting and financial continuity and in accordance with the announced budget.

04 finances

income statement

In 2019, revenues were made up of real estate incomes from the initial endowment, subsidies, donations from public fund-raising, and institutional and private partnerships. These resources amounted to €410,792. Operating expenses amounted to €653,109.

Break-even is obtained by an extraordinaryincome of €291,438.

The Foundation is not subject to taxes and does not pursue for-profit activities.

- Total operating revenue for the year was €410,792, compared to €510,490 for the previous year.
- Total operating expenses for the year amounted to €653,109, compared to €713,268 for the previous year.
- Extraordinary income amounted to €291,907, and exceptional expenses to €469.
- The net result is at break-even.


70.7% of the total assets are fixed assets, of which 93.9% are real estate assets from the Foundation's endowment. The remaining 29.3% is divided between 99.9% of current assets, 83.5% of which are assets awaiting investment, and accruals.

liabilities

The net equity is €4,158,154. It includes the previous deficits accumulated by the Henry Dunant real estate fund, which affect the Foundation's retained earnings of €858,846. The other debts are mainly due to the spreading of research payments over two calendar years.



It must be noted that:

- The accounts were established following the same principles and evaluation methods as the last year, and comply with existing legislation
- No investment was made in companies headquartered in the territory of the French Republic
- A Financial Committee assists the Board with regard to financial investments, the management of resources, and the control of budgets and financial accounts
- Annual accounts are available on the Journal Officiel website
- Events after the closing of accounts: the COVID-19 epidemic that is currently affecting France, but also the countries in which the French Red Cross Foundation conducts research, is likely to impact the activities of the French Red Cross Foundation. However, it is difficult to predict the impact of this epidemic on our activity in 2020 as of April 1. To date, business continuity is ensured.

We certify that, in light of French accounting rules and principles, the annual accounts are regular, sincere, and give a faithful picture of the result of the operations over the past year, as well as of the Foundation's financial situation and assets at the end of this year.

outlook for 2020

In 2019, the Foundation moved onto the Campus of the French Red Cross, marking the beginning of an unprecedented collaboration between the teams of the FRC and the Foundation's community of researchers. The proximity of people and skills has allowed for detailed consultations and exchanges regarding the roadmap to be drawn up for the organisation, which is fast developing. The Foundation's Governing Board, Scientific Council, associated experts, partners and team members worked throughout the year to define the main axes of the 2020– 2024 strategy, which will be voted on at the beginning of 2020.

By 2020, building on the humanities, the Foundation focuses on three of the five challenges to be metof the IFRC 2030 strategy: access to health/epidemics, migration, crises and disasters. The Foundation will continue its efforts as an active member of the new RC3 Research Consortium to support an improved, useful and considered scientific approach, guaranteeing a strong link between the results that are produced and the transformations to be made with regard to actions. In addition, its territories of action are confirmed, with about twenty projects deployed and/or to be identified in Metropolitan France, overseas territories and Sub-Saharan Africa.



Virginie TROIT Director From listening to the needs of the teams to promoting and integrating the results into practice, the Foundation will continue to improve and develop its means of action. The first non-individual research projects will be added to the postdoctoral fellowships, as well as the possible valorisation of theses or master's work related to Red Cross fields. Volunteers will also have the opportunity to become scientific leaders by pairing up with researchers in the context of the new Bénévo'Lab programme. The editorial strategy will be operational for the first time on all levels: scientific articles (the Papiers de la Fondation), coediting of journals (Humanitarian Alternatives), book editing (Devenir Humanitaire), public dissemination ('Practices & Humanities' series). The Foundation will continue to promote an ever more open, inclusive and impactful dialogue involving a multitude of actors, by organising or contributing to international events in the Indian Ocean, in Saint-Denis de la Réunion and in Beirut. Finally, we look forward to the results of the selection jury for the 2020 Research Prizes.
