Foreword

A turbulent start to the decade has been followed by constant and sometimes chaotic and even brutal change, creating an unpredictable environment to which the International Red Cross and Red Crescent Movement has had to adapt.

Understanding and addressing this emerging reality requires constant scientific scrutiny of the facts. The French Red Cross Foundation's unequivocal response has been to produce knowledge that drives transformative change in solidarity and humanitarian action, both in France and across the globe.

Established a decade ago, the Foundation has seen the need for clear-sightedness and innovation acquire a new and broader significance. We have used this symbolic ten-year milestone to collaboratively redefine our strategic focus with our ecosystem and the French Red Cross in order to adapt to the evolving humanitarian landscape. The Foundation now increasingly structures its work around action research, international partnerships and stakeholder networking.

The Foundation's support for research is therefore grounded in real-world experiences. This year, we awarded nine grants to projects designed to provide the humanitarian community with practical solutions, from building community disaster resilience and giving greater consideration to the mental health of learners in health and social care training to promoting positive attitudes towards refugee reception centres.

By cultivating strong relationships with operational stakeholders, the Foundation ensures its work remains relevant. In 2024, we went a step further by organising our first Emergence Workshops. Providing support to humanitarian actors, these sessions identify research topics arising directly from their questions, to jointly develop their projects. With the same objective of promoting knowledge and making it as widely available as possible, the Foundation has published over twenty new 'Pratiques & Humanités' briefs outlining the research it supports.

A bridge between the worlds of academia and operational actors, the Foundation has also demonstrated its ability to put across its own distinct point of view. Now a recognised player in humanitarian research, the Foundation is a familiar sight at events and conferences, including the 34th International Conference of the Red Cross and Red Crescent Movement in Geneva, and has expanded its role within the research consortium alongside other actors within the Movement.

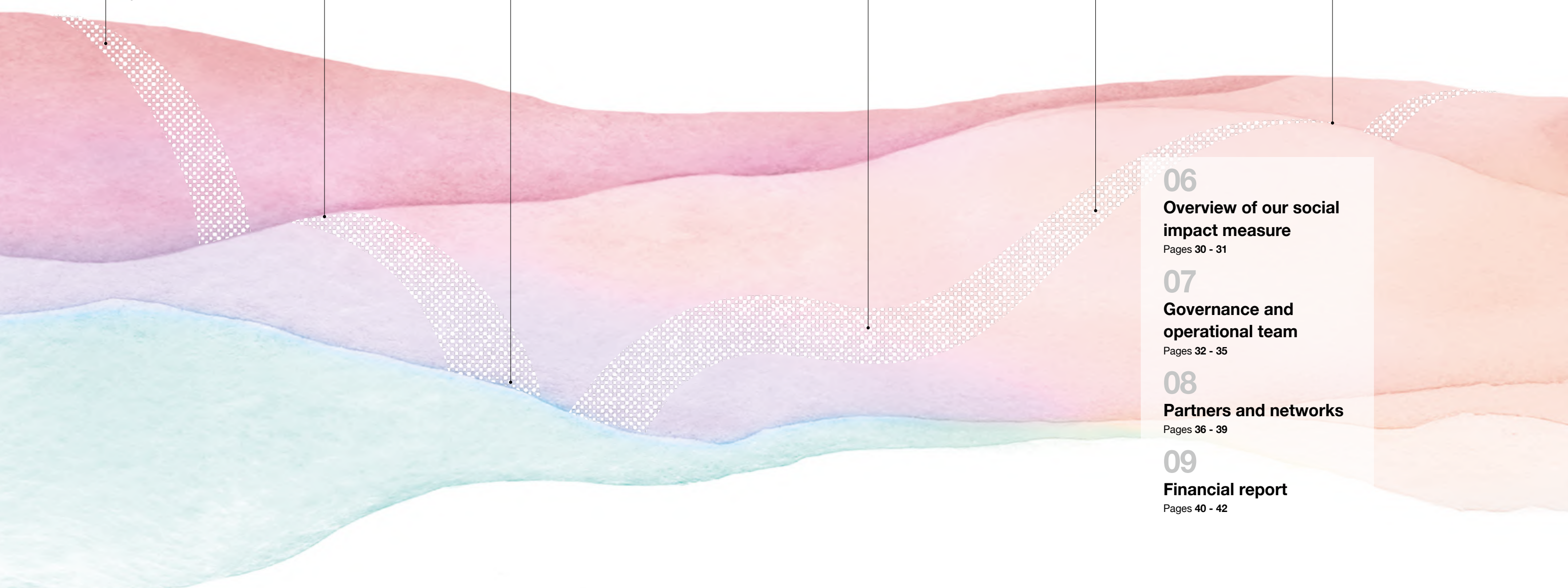

01 Our purpose

Supporting research and improving practices

The French Red Cross Foundation is a recognised public utility foundation dedicated to research in the humanities and social sciences. It aims to improve practices in the fields of humanitarian and social action, in France and all over the world through research. It supports researchers by providing fellowships and awardings and developing collaborations with academic institutions. To successfully complete its actions, the Foundation follows the values and principles of the International Red Cross and Red Crescent Movement, and is based on the scientific expertise and methodologies that guarantee its efficiency and form the basis of its identity.

Our three levers for action

Research

The Foundation supports research by allocating postdoctoral fellowships, constructing research programmes in cooperation with partners and awarding research prizes to innovative or deserving researchers.

Publications and events

The Foundation disseminates knowledge through a range of editorial projects in order to improve the impact of the research results and make them available for different audiences. The Foundation takes part in the global debate by organising or participating in events, to disseminate and promote research for the benefit of the most vulnerable.

Transferring knowledge

The Foundation is working to move away from a 'classical' approach of supporting the production of scientific knowledge followed by the mobilisation of the knowledge acquired, and towards a social research and development approach that strengthens the potential for transformation and innovation based on research findings.

Map
of current research

In 2024, the Foundation selected and accompanied a total of 19 francophone researchers, working in 7 countries. Despite their varied methodologies, disciplines and approaches, the researchers share a common goal: shedding light, by means of the tools of the social sciences and humanities, on realities and social experiences in the field, as well as on the needs of vulnerable people, to enable the emergence of innovative and sustainable solutions for humanitarian and social action, based on scientific data.



4 priority themes

Humanitarian Transition
The Foundation's core programme

Anticipating and addressing the challenges arising from the current evolution of the humanitarian sector, by studying these major changes in terms of operational models, new partnerships, and reconfiguration of the roles of actors.

Risks and disasters

Studying the causes of population vulnerabilities, the relevance of their preparedness, and their perception of risks, as well as the innovative humanitarian responses trialled in the most affected areas. This theme also addresses the issue of the resilience process in light of climate change and environmental pressures.

Health and epidemics

Understanding populations' health situations and needs, taking into account the socio-cultural dimensions in actions relative to access to care, disease and epidemic risks prevention, and strengthening healthcare systems.

Migrations and displacements

Better grasping the origins and sources of migrations, the strategies and lived experiences of exiles, and the relevance of the humanitarian response. Accompanying the renewal of practices concerning this issue which has taken on a global importance.

02 Highlights of 2024



March

The Foundation launches its new calls for applications. Five calls, each focusing on one of the Foundation's key research priorities, are published between March and April 2024.



April

The Foundation takes part in the presentation of the 2024 report on the resilience of the French society 'Extreme Climate Events: Are We Ready for the Inevitable?' issued by the French Red Cross and CREDOC, to which it contributed.



May

- As part of a *Pause-Culture-Recherche* at the Red Cross Campus, the Foundation welcomes Historian Joël Glasman to discuss his book 'A Short Self-Defense Guide for Volunteers'.

- A new episode of the *Instant Recherche* webinar brings together an expert from the Global First Aid Reference Centre and a researcher in education sciences to explore how life-saving skills are taught and learned.



June

- As part of a second *Pause-Culture-Recherche*, the Foundation welcomes Historian Romain Fathi to speak about the French Red Cross's public health shift in 1919 and the beginning of its remarkable expansion.

- After ten years of commitment to humanitarian and social research, the Foundation presents the results of its social impact assessment, in a first dedicated report.

July

- The Board of Administrators awards nine new one-year postdoctoral research fellowships, with the support of the Foundation's partners.



- The 'research ideation workshops', a new initiative aimed at helping stakeholders articulate research needs, are launched. The first workshop is taking place at the Red Cross Campus, in collaboration with the French Red Cross's Inclusion Department and the organisation Solinum.



September

- Continuing its active contribution to the RC3 Consortium, the Foundation takes part in the 2024 Global Workshop in Seoul, South Korea, organised in partnership with the Korean Red Cross Society.



October

- As part of the 160th anniversary of the French Red Cross, the Foundation co-organises the conference 'Music and International Humanitarian Law: Two Utopias in Times of War?' during the Haizebegi Festival in Bayonne.



- The Foundation also participates in the 80th anniversary of its historical partner, the *Institut de recherche pour le développement*, in Marseille, where it delivers a speech at the opening round table, through her vice president.

- Food aid is the focus of an episode of the *Instant Recherche* webinar, entitled 'Emergency and Sustainable Challenges: Reinventing Food Aid'.



November

- The *Rencontres de la Fondation* take place at the *École des Mines* in Paris, bringing together researchers and practitioners to discuss the research projects supported by the Foundation.



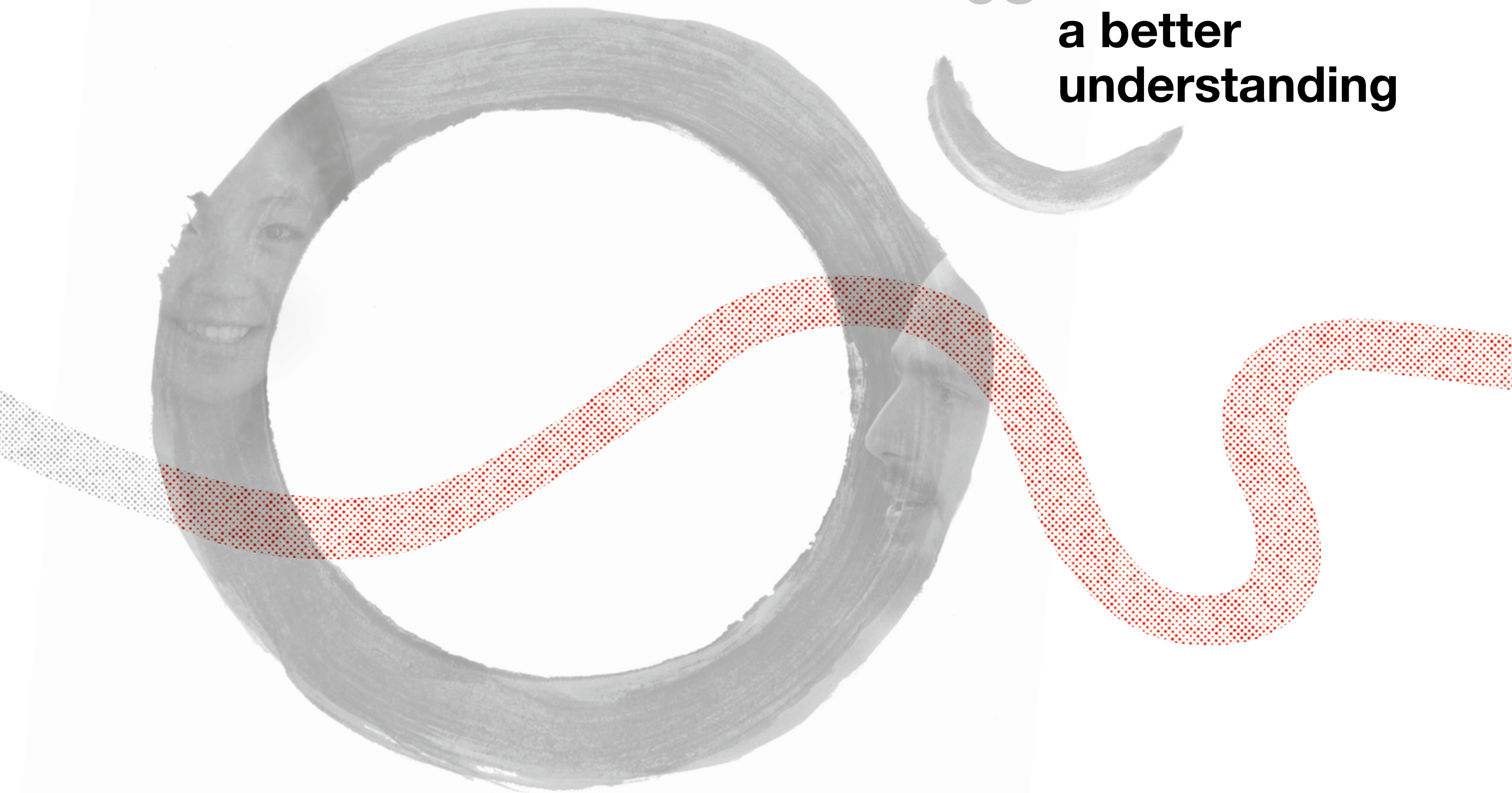
December

Research supported in 2024

13 projects sorted by research theme

Research projects supported by the Foundation usually span two calendar years, and may therefore appear in two consecutive annual reports.

Risks and disasters

1 Rethinking disaster risk reduction (DRR) through social action and everyday resilience strategies in Chad.

Virginie LE MASSON

Doctor of Geography, ODI London.

Conceptualising the link between everyday resilience of populations exposed to multiple hazards and crises and DRR, compare humanitarian and development interventions in the way they take into account social factors of vulnerability, and articulate avenues for DRR reform that are more rooted in everyday experiences, taking into account the intersectionality of vulnerability factors.

2 Perceptions of risk, risk management strategies and responses to disasters of 'natural origin' in the overseas territories of the Indian Ocean: Mayotte and La Réunion.

Morgane ROSIER

Doctor of International Development, University of Ottawa (Canada).

Analysing the perceptions of different stakeholders in the management of risks of 'natural origin' in Mayotte and La Réunion, in order to gain an understanding of the shortcomings of risk management strategies and emergency responses, and thus improve their communications and practices.



3 Resilience to climate change in Togo: ethnography of endogenous knowledge and practices of preparation, protection and adaptation to the health impacts of flooding in the lower Mono River Valley.

Kossi Mitronougna KOUMI

Doctor of Socio-Anthropology, EHES and University of Lomé (Togo).

Documenting the positive endogenous knowledge of preparation, protection and adaptation of the populations of Agbétiko Township to the health impacts of flooding, so that it can be better taken into account by these actors in the construction of responses.

4 Digital resilience practices in the face of flood risks in the Abidjan District (Côte d'Ivoire).

Khan KOUAME

Doctor of Communication Sciences, Alassane Ouattara University, Bouaké (Côte d'Ivoire).

Meeting the challenges posed by the risk of flooding in Côte d'Ivoire, and Abidjan in particular, by stepping up training and raising people's awareness of good 'digital resilience' practices.

Humanitarian transition

5 'By us, for us': self-managed humanitarian initiatives by Sudanese refugees in Jordan.

Solenn AL MAJALI

Doctor of Anthropology, University of Aix-Marseille.

Studying the role of refugees in Jordan in the system of humanitarian governance, in a context of humanitarian transition and the localisation of aid, with a particular focus on the self-managed initiatives of Sudanese refugees in the humanitarian ecosystem in Amman.



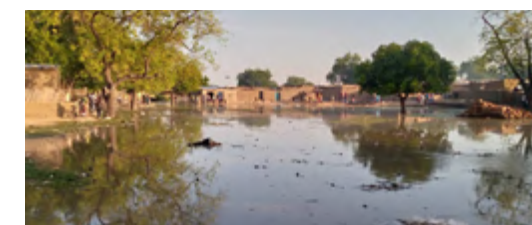

Tetiana STOIANOVA

Doctor of Law, University of Odessa (Ukraine).

Identifying a reliable method to measure loneliness and an effective approach to reducing loneliness among Ukrainian refugees in order to improve their social connections within their host society and alleviate the psychological violence they may experience.

Research awards The 2024 laureates

Open to all disciplines in the humanities and social sciences and to all nationalities, the French Red Cross Foundation's research prizes reward scientific excellence and human commitment. In 2024, the jury, made up of members of the Foundation's governing bodies, awarded three prizes, including a future prize for a promising young researcher and an honorary prize for lifetime achievement. The 2024 prizes were awarded with the support of the Andorran Red Cross and are worth €3,000 (excluding the honorary prize).

Doctor of International Relations and Political Science, Director of the Centre for Operational Research and Experience of the International Committee of the Red Cross in Geneva.

Honorary Prize 2024 for her career as an academic and practitioner in the field of humanitarian affairs, marked by more than 30 years of field experience and research work whose significant contribution to the understanding of humanitarian policies is internationally recognised.

Elliot RAKOTOMANANA

Doctor of Health Anthropology, head of the 'Health and Social Sciences' team at the Pasteur Institute of Madagascar.

Prix avenir 2024 for his exceptional career, marked by his dual training in food science and anthropology, which enables him to take a multi-faceted analytical look at child malnutrition and public health problems in Madagascar.

04 Towards more effective action



Action research supported in 2024

6 projects sorted by research theme

The action-research projects supported by the Foundation respond to research questions formulated on the basis of needs expressed by practitioners from the French Red Cross or other entities of the International Movement. In this type of research, practitioners participate in all stages of the research, defining with the researcher the problem and the collective working methods.

All the action research projects presented in this double-page spread are conducted with the support of the French Red Cross.

Migration and displacements

1 Welcoming and accompanying asylum seekers on the day of their OFPRA interview: the Oasis study.

Project carried out by the Migration and Society Research Unit (URMIS).

Setting up an action research project designed to document the effects of the experimental reception facility for asylum seekers, known as the Oasis, on the people it welcomes.

2 Refugee peer helpers: volunteering by and for refugees, an alternative model for integration?

Leila DRIF

Doctor in Social Anthropology, EHESS.

Studying the specific features of volunteering by migrants, in the context of the reception system in France, in the light of their migratory experience.

3 Forms of self (re)presentation and imaginary clothing: practices and uses of clothing in precarious situations.

Emmanuelle DURAND

Doctor in Anthropology, IRIS-EHESS.

Exploring the meanings associated with clothing and their role in the self-representation of first-time migrants in order to suggest ways of improving the services and support offered in the French Red Cross clothing stores.

4 Hybrid format training courses to improve first aid training efficiency.

Anne MULLER

Doctor in Education Sciences, University of Paris 1 Panthéon Sorbonne.

Understanding how hybrid first aid training for the general public can improve the knowledge and skills acquired, the confidence of learners, their feeling of competence, their willingness to act and their ability to act in an emergency situation, as well as the practice of actions learned in training.

The Bénévo'Lab programme



Bénévo'Lab is our flagship programme for strengthening the link between research, action and society. It is a participative research programme within the French Red Cross family, initiated by those who carry out the actions on a daily basis, i.e. the volunteers and employees. The idea is to enable them to find insights and solutions to the difficulties they may encounter in the course of their work. The Foundation is proposing to provide them with a think-tank to support them, through tailor-made research aimed at providing a clear and operational response.

At the end of the 2024 call for proposals, two research proposals were selected. They were then submitted to the scientific community and two researcher-volunteer pairs were put together and monitored by the Foundation's team.

5 Understanding and promoting the social acceptability of new reception facilities for asylum seekers.

Isabelle WILHELM, Doctor in Anthropology, Free University of Brussels (Belgium).

Project proposed by the 'ex-peer advisers' of the French Red Cross.

Identifying the determinants influencing the social acceptability of asylum seekers and propose strategies to improve the integration of new reception centres by local populations.

6 Well-being and mental health of French Red Cross learners.

Jean-Luc RINAUDO, University Professor of Education Sciences, Rouen-Normandie University.

Project proposed by Croix-Rouge Compétence, the health-and-social training branch of the French Red Cross.

Shedding light on the mental health of learners undergoing vocational training in Red Cross health and social work schools in France.

"The Bénévo'Lab programme offered by the Foundation enables research to be carried out on issues identified by French Red Cross volunteers. Research ideation workshops

Enhancing interaction between civil society and the research community

What are they?

Research Ideation Workshops help the French Red Cross and non-profit/civil society organisations express and identify research needs and questions through cooperation with researchers to create mutual learning opportunities.

These workshops are for organisations seeking either to connect with academics for the first time, strengthen their analytical framework or build knowledge for informed action, or those already exploring joint research projects. They help identify pathways for collaboration between academia and civil society, which may often be distant from the research world.

What do they involve?

The moderators of these workshops, which last several hours, use issues flagged by ‘field’ actors to identify an original research question with substantial scientific merit. This jointly constructed question, which evolves with the project, is the first step in a collaborative research process that integrates civil society actors at all levels of the research project, from defining the topic to adopting new and shared knowledge. The purpose is to help ‘translate’ a ‘field’ insight into a topic for scientific research.

The workshop begins with introductions, followed by plenary input sessions on the challenges of action research, criteria for formulating research questions, and conditions for project success at every stage. Participants engage in individual and group work sessions designed to leverage collective intelligence and foster practical advancements. Regardless of whether a formal project emerges, these sessions equip each participant with the skills to structure and critically evaluate a project.



Example

In 2024, the Community Advisory Drop-in Centres (ALSO) department, part of the inclusion service of the French Red Cross, and the non-profit Solinum approached the Foundation to explore inter-organisational research on the impact of a new drop-in, listening and advisory mechanisms to optimise user services.

The first research ideation workshop, held in July, identified seventeen key research questions and needs. A second session in November sorted and grouped these questions and identified the main common themes before taking a final collective decision on the research direction. Based on roundtables, votes, decision-making and discussions on individual working forms and procedures, the two-session workshop determined key aspects of the research project, launching in 2025.

What is the RC3?

Founded in 2019, the RC3 (Red Cross Red Crescent Research Consortium) is an open, collaborative and coordinated network of entities and initiatives dedicated to conducting and promoting humanitarian research within the International Red Cross and Red Crescent Movement. In 2024, the RC3 had 23 active members across five continents, including the research departments of National Societies, global and regional reference centres, and knowledge production and acquisition entities created by National Societies, including foundations, academies, institutes, observatories and platforms.

Global RC3 Research Workshop in Seoul

Every year since 2019, the RC3 has organised a global workshop for its members. Its three goals are, first, to strengthen peer-to-peer support on scientific and organisational issues; second, to ensure the Consortium's development based on a shared vision, renewed governance and an adapted economic model; and third, to adopt an action plan targeting both the scientific community and volunteers and professionals within the humanitarian sector. The 2024 workshop, co-organised with the Korean Red Cross and the IFRC's Asia Pacific Disaster Resilience Centre (APDRC), took place in September in Seoul, South Korea.

Research Spotlight at the 34th International Conference of the Red Cross and Red Crescent

The International Conference of the Red Cross and Red Crescent is the Movement's supreme deliberative body. It is the forum in which the delegates of the Movement and State signatories to the Geneva Conventions come together to debate and make joint commitments on key humanitarian issues. The 34th conference was held in Geneva between 28 and 31 October 2024. The RC3 hosted a round table to underscore the vital role of research in strengthening our capacity to advance within an uncertain world and amplify the impact of humanitarian action. The round table, co-chaired by the Foundation's Director General and the Director of the IFRC's Global Disaster Preparedness Center, brought together the Vice President of the IFRC, the Vice President of the ICRC, a representative of the Norwegian State, and two representatives from National Societies engaged in research programmes. An opportunity for participants to engage in a dialogue on existing research initiatives, the round table demonstrated

how research can enhance operational impact, improve advocacy and better meet the needs of affected communities.

06 Overview of our social impact measurement process



Assessing public benefit initiatives is essential to ensure their relevance and effectiveness, while strengthening the trust of citizens and partners. The Foundation has therefore been committed to measuring its social impact since 2023. Based on six specific and objective criteria divided into two complementary areas, science, on the one hand, and humanitarian and social issues on the other, this measurement is a lever for better responding to contemporary challenges and anchoring our organisation's impact in a process of continuous improvement.

For each of the six criteria of impact, a three-step process allows us to assess the Foundation's impact through three categories of indicators: **achievement** indicators, **results** indicators and **usefulness** indicators.

This double page presents a summary of the elements used to measure the Foundation's social impact for the year 2024.

In the academic field, the Foundation is committed to:



€201,188 invested in research (funding allocated in 2024 to researchers or research organisations).

7 scientific articles in the *Papiers de la Fondation* series.

4 publications by researchers supported in peer-reviewed books or journals (list of publications on p. 24).



5 research projects focusing on the activities of the French Red Cross:

60 % of international research is conducted by researchers from the country concerned. This figure is up from the average of 55% between 2013 and 2023.

The publication of *Pratiques & Humanités* continues its momentum with **24 publications** in 2024, bringing the total to **51 since 2020**, reflecting an acceleration in the production and dissemination of these policy briefs to reach professional audiences.

Three episodes of the podcast *En-Quête d'Humanité* were recorded and broadcast on dedicated platforms to promote the contribution of social sciences to the general public.

42% of projects supported in 2024 involve an entity of the international Movement, a figure above the average of 29% for the period 2013–2023, demonstrating a desire to strike a good balance between action research and the production of more general empirical research.

In addition, the Foundation has set up a Post-Research and Social Innovation Workshop (APRIS), organised at the end of 2023 at the Red Cross Campus, which brought together several departments of the French Red Cross to strengthen socio-aesthetic projects based on the work of sociologist Thibaut Besozzi.

Operational impacts following this APRIS:

- Establishment of an impact measurement to lend credibility to the initiative
- Development of a national project sheet dedicated to socio-aesthetics by Croix-Rouge Initiatives (2024)
- Presentation of an action plan by the Innovation Department to the Inclusion Department of the French Red Cross (2025).

07 Governance and team

The French Red Cross Foundation is governed by four bodies. The **Board** is made up of twelve administrators, divided into four colleges. It is chaired by Mr Philippe Da Costa. In the 2024 financial year, it met four times, in April, July, October and December. To develop its scientific mission, the Board is assisted by a **Scientific Council**, composed of 16 members with recognised expertise in the Foundation's areas of activity. A group of 23 **Associated Experts** completes this multidisciplinary and multisectoral scientific governance structure, bringing together committed professionals from several continents. A **Finance Committee** advises the Board, approves the annual accounts and makes recommendations on financial matters.

09 Financial report

Finances and presentation of annual accounts

The French Red Cross Foundation's financial statement for the year ending 31 December 2024 represents the eighth one since its recognition as a public service entity on 1 September 2017. In 2024, the Foundation reported a negative balance of €46,000, an improvement on the 2023 one, which stood at €96,000.

A very active year for scientific missions

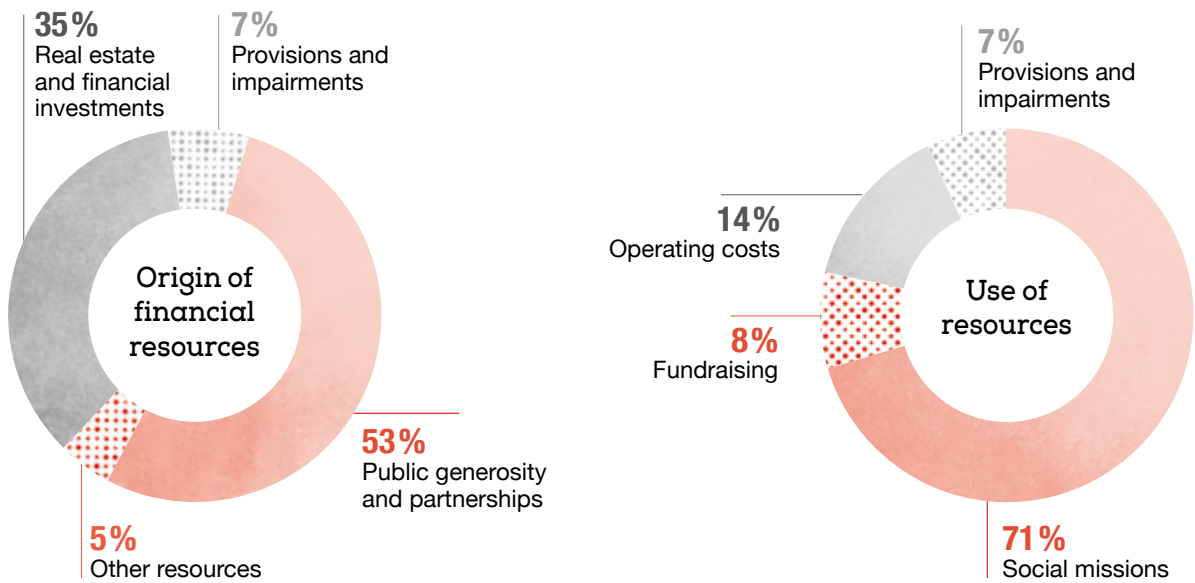
During the 2024 financial year, the French Red Cross Foundation was particularly active in the field of scientific research, signing partnership agreements to fund 11 new research projects, compared to 4 in 2023, for a total of €260,000 in 2024, compared to €95,000 in 2023. At the same time, 17 researchers completed their work in 2024, compared to 7 in 2023, which will be published in 2025.

The Foundation has also demonstrated its influence beyond the International Red Cross and Red Crescent Movement, with 73% of research funded by private partners outside the Movement, whereas in 2022 and 2023 most of the funding came within the Movement.

Diversified resources

To preserve its independence and carry out its research missions, the Foundation continues to pursue its resource mobilisation strategy by significantly diversifying its funding in France and abroad:

- Real estate rental income,
- Partnerships with the private sector, businesses and foundations,
- Partnerships with the entities of the French Red Cross and the International Red Cross and Red Crescent Movement,
- Appeals to public generosity,
- State subsidies,
- Sponsorship of services and expertise,
- And, to a lesser extent, income from financial investments.

The 2024 results feature the following key highlights:

- The increase in revenue recognition (+1%) from research partnerships reflects the vitality of research projects underway in the 2024 financial year,
- The decrease in property income is due to unpaid rent on three properties,
- The financial result is slightly up due to new risk-free instruments income,
- Finally, operating expenses are under control, demonstrating rigorous cost management in a challenging environment.

In 2024, the main balance sheet ratios remain stable:

- Assets consist of 72% fixed assets, mainly real estate and financial investments, which strengthen the Foundation's endowment,
- Cash and cash equivalents remained unchanged at €1.4 million,
- The slight decrease in equity is solely due to the deficit for the year.

10 Outlook for 2025

Despite a year so far dominated by an uncertain geopolitical climate, the French Red Cross Foundation, guided by its firm values, remains steadfast in its commitment to support humanitarian action, the very structure of which is now under threat. It will therefore continue to focus on humanities and social science research, action research and social innovation through knowledge transfer to help address the institutional, operational and ethical challenges confronting humanitarian and social action. As a meeting point for academics, civil society organisations and target populations, the Foundation is now more committed than ever to generating knowledge and transforming the practices and knowledge acquisition of frontline organisations. In 2025, the Foundation will proceed with its missions in mainland France, French overseas territories, and neighbouring foreign states within the Atlantic, Indian and Pacific basins, as well as in Sub-Saharan Africa and the Middle East. It will continue to adopt a resolutely inclusive, open and collaborative approach to the humanities and social sciences, focusing on the needs of people and places.

In 2025, our scientific programme, in collaboration with private partners and the International Red Cross and Red Crescent Movement, will award prizes and fellowships, oversee multi-regional research, deploy the emergence research programme in Mayotte in response to the devastating impact of Cyclone Chido, and implement the French Red Cross volunteer Bénévo'Lab programme. In addition to generating new research, the Foundation will continue to foster a culture of research through its Pause-Culture-Recherche sessions at the Red Cross Campus, French-language Instant Recherche webinars, and annual international gatherings. The Foundation will also focus on jointly facilitating spaces, networks and publications where humanitarian actors and academics can interact and engage in a creative dialogue.

The unprecedented drop in international funding from traditional international aid donors is not expected to affect the Foundation directly in 2025. Nevertheless, uncertainty surrounding the impact of this decline on the humanitarian system and its short- and medium-term consequences for people, coupled with threats to universities and science, underscores the need to strengthen our economic model and adaptability. In the short term, this will mean streamlining our property portfolio, building our management, finance and research engineering capacities and adopting a more strategic approach to alliances and partnerships.

In summary, this year will undoubtedly mark a turning point for humanitarian aid and the defence of academic values. The Foundation must stand ready to act in a more challenging environment while building an increasingly productive, supportive and effective knowledge space that upholds humanitarian principles.
